Understanding Chemical Abuse and Dependency

TARGET AUDIENCE

This program is designed for registered nurses working in various practice settings. The content would be of value to any healthcare professional.

GOAL OF THE PROGRAM

To increase the learner's knowledge of the diagnosis of chemical abuse and dependency and to better understand the most current treatment modalities in order to improve nursing care and patient outcomes.

- Identify various modalities of psychological treatment for chemical dependency and abuse, including REBT (Rational Emotive Behavior Therapy).
- Understand current trends in substance abuse and treatment amongst the child and adolescent population.
- Explain how genetics, environment, and development play a role in determining why some people become addicted and some do not.
- Discuss medication management through the detox/withdrawal process and maintenance afterwards.

COURSE DESCRIPTION

Join us as we proudly welcome four of Acadiana's own local experts from Vermilion Behavioral Health Systems (also known as Vermilion Hospital) who will share their insight and knowledge into a complex disease process called chemical abuse and dependency.

A registered nurse, social worker, nurse practitioner, and physician will explore a wide array of topics such as changes to the DSM, treatment of military personnel, and the latest addictive substances which lead to abuse and dependency. Presenters will also discuss chemical abuse throughout the lifespan by focusing on current trends in the child and adolescent population. Lastly, experts will delve into the detoxification and withdrawal process, including the difficulties patients face in sustaining sobriety.

Due to the high incidence of chemical abuse and dependency we see today, nurses from a variety of fields can incorporate this in-depth and timely information into their practice.


